ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the symbols and indications on Map Number 1-H in the area bounded by described as following:

- a) from the C2-1 Motor Vehicle-Related Commercial District and M1-2 Limited Manufacturing/Business Park District and RT-4 Residential Two-Flat, Townhouse and Multi-Unit District,

West Grand Avenue; Damen Avenue; West Ferdinand Street; a line 270 feet east of and parallel to North Western Avenue

to those of C3-2 Commercial, Manufacturing and Employment District

2001 - 2331 West Grand Avenue

- b) from the C1-2 Neighborhood Commercial District and M1-2 Limited Manufacturing/Business Park District,

a line 270 feet east of and parallel to North Western Avenue; a line 105 feet south of and parallel to West Grand Avenue; a line 115 feet east of and parallel to North Western Avenue; West Grand Avenue; North Western Avenue; the public alley next north of and parallel to West Grand Avenue; North Claremont Avenue

to those of a B3-3 Community Shopping District

2333- 2347 West Grand Avenue

2332- 2358 West Grand Avenue

- c) from the C1-2 Neighborhood Commercial District and M1-2 Limited Manufacturing/Business Park District and RT4 Residential Two-Flat, Townhouse and Multi-Unit District

North Claremont Avenue; the alley next north of and parallel to West Grand Avenue; a line 264 feet east of and parallel to North Oakley Avenue; West Grand Avenue

to those of a B2-2 Neighborhood Mixed-Use District

2234- 2326 West Grand Avenue

d) from the M1-2 Limited Manufacturing/Business Park District

a line 264 feet east of and parallel to North Oakley Avenue; the alley next north of and parallel to West Grand Avenue; a line 168 feet west of and parallel to North Leavitt Avenue; West Grand Avenue

to those of a C2-2 Motor Vehicle-Related Commercial District

2218- 2224 West Grand Avenue

e) from the C1-3 Neighborhood Commercial District

North Leavitt Avenue; the alley next north of and parallel to West Grand Avenue; a line 175 feet east of and parallel to North Leavitt Avenue; West Grand Avenue

to those of a B2-3 Neighborhood Mixed-Use District

2158 West Grand Avenue

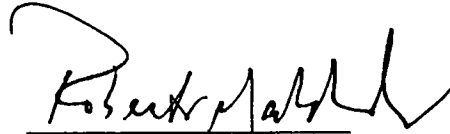
f) from the C1-2 Neighborhood Commercial District and M1-2 Limited Manufacturing/Business Park District and RT4 Residential Two-Flat, Townhouse and Multi-Unit District and B3-3 Community Shopping District,

a line 175 feet east of and parallel to North Leavitt Avenue; the alley next north of and parallel to West Grand Avenue; a line 96 feet west of and parallel to North Damen Avenue; West Grand Avenue

to those of a B2-2 Neighborhood Mixed-Use District
