The following is said ordinance as passed:

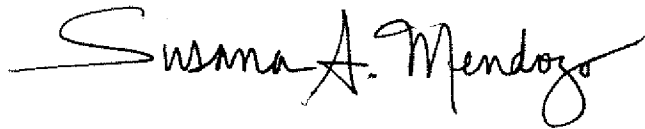
Be It Ordained by the City Council of the City of Chicago:
